### LETTER FROM THE EXECUTIVE DIRECTOR

Dear Utah County Residents and Community Leaders:

With the COVID-19 pandemic and the demands place upon public health, it has been challenging to find time to reflect on the year 2019 and its accomplishments. Putting the demands of the pandemic aside for a few minutes, I will try to focus on a few of the many important events, services and accomplishments from 2019.

A highlight for early in the year was the opening of the Payson Clinic in January of 2019 for walk-in Vital Records (birth and death certificates) and immunization services, along with scheduled WIC services. We partnered for services in a building with Wasatch Behavioral Health and the Utah County Department of Alcohol and Drug Prevention and Treatment. In opening this facility, we have been able to provide more convenient walk-in services for our south county residents.


Due largely to additional monies provided to the school districts by the legislature, coupled with some additional school district and health department funds we were able to strengthen our school nursing program by adding 11.75 FTE nurses to the Alpine School District, .75 FTE nurse to the Nebo School District, and .25 FTE nurse to the Provo City School District. The addition of these nurses will enhance our coordination with the school districts in protecting the health of our children, our most precious resource.

Early in 2019, we worked closely with two of our county cities, Cedar Hills and Lehi, as they implemented Tobacco 21 laws which made it unlawful to sell tobacco products to anyone under the age of 21. This important action, by these cities, led directly to the legislature passing a state-wide Tobacco 21 law during the 2019 legislative session.

As most residents are aware, Utah County's population is growing rapidly. A significant portion of this growth has been taking place in and around Utah Lake. This growth pattern has made mosquito abatement a challenge in many of these areas. It has become more difficult to get staff on four wheelers into some of the more problematic areas of mosquito breeding and has made air spraying these areas from a plane impractical. To better treat these mosquito breeding areas, the use of drones for treating areas with larvicides was begun in 2019. So successful were the reductions in mosquito numbers from the use of the drone service, we anticipate expanding the service to additional areas as funding permits in 2020.

With the changing world of communication, we continue to develop our social media communications following a robust social media strategy. We continue our presence on Facebook, Twitter, Instagram and other platforms. Our Public Information Officer, Aislynn Tolman-Hill oversees the creation and development of social media content and messaging including videos, livestreaming and animated explainer-videos. Social media content may promote current health department programming and initiatives or be in response to emergent public health needs.

We look forward the challenges that will come in 2020, along with the opportunities that come with those challenges. We appreciate all the support we receive from our Utah County Board of Health, Utah County Commission, Utah County mayors and city councils, the many community organizations we enjoy partnering with, and from the citizens of Utah County. We hope to continue to provide the very best in public health services to our citizens.

## **SERVICE STORIES**

### NURSING/HOME VISIT PROGRAMS

I had an infant with a heart defect that the Doctor was watching and having come in every few months. They were hoping to get the baby to 9 months and then do surgery. However, with a Welcome Baby visit I found that the infant was not growing and with a call to the heart doctor surgery was scheduled right away. We were able to catch this earlier than what might have otherwise happened thanks to the additional visits for this infant. - Nurse Cindy

I found a mother living in a trailer home with a preemie baby during the month of October with no heat because she couldn't afford it. We got her the resources she needed to get heat and followed the baby for a year to make sure he met his milestones. The mother had a 5th grade education and spoke Spanish. Our visits took extra time because she couldn't read the information I was sharing in Spanish. We have her a pack-n-play for baby, to provide safe sleep, because the family was co-sleeping on the same bed. It was clear that the baby was hypertonic (common for premeemies) standing on tiptoes and pointing his toes while lying down. As he got older, we provided activities and stretches mom could do with the baby to help him stand and balance flat footed. We performed developmental screenings on baby every 2 months and referred him to Kids on the Move (early intervention). After about 6 weeks he was walking flat footed and mom was thrilled! Everyday I am more convinced of the importance of this program. - Nurse Janeen

### **ENVIRONMENTAL HEALTH**

I submitted a complaint/concern to the Environmental Health staff of the Health Department due to unsafe and possible unsanitary conditions at a restaurant. Not only were they were professional and polite, they let me know that they would be doing an inspection and then followed up with me. When I think about the amount of complaints they must get for the size of Utah County, I was very impressed. I appreciate the work they do to keep us all healthy and safe. - Mike (resident)

### **HEALTH PROMOTION**

UCHD's Quality Improvement Coordinator, Kylaas Flanagan, is part of the Emergency Preparedness and Response Team and took on the major task of creating a Training and Exercise Plan for the Department. While the project was a need for UCHD's emergency preparedness and planning, it was also a major need for the department as a whole. One part of creating the Training and Exercise Plan was to ensure that all UCHD staff were trained in the Incident Command System (ICS) to respond to emergencies in a uniform fashion. Kylaas assured that 100 % of UCHD staff completed appropriate required ICS training. Achieving the 100% staff participation was 20% over the national benchmark for public health preparedness training. Beyond training, Kylaas also set up a system to track staff ICS training and ensure that all new staff receive training as well.

Having employees like Kylaas in the division of Health Promotion and throughout the whole department shows the level of dedication, professionalism and follow-through that UCHD ensures in order to provide a a high level of customer service to the public, whether it be through one-on-one services or through high-level strategic planning. - Eric Edwards (Deputy Director), Aislynn Tolman-Hill (Public Information Officer)

### FOSTER GRANDPARENTS

Grandpa Bill: Bill has been coming into my class to assist four student this year in their reading skills. I will refer to them as 1 "J", "S", "B" and "A". I have watched all four of these students progress and improve in their reading skills because "Grandpa Bill" works with them and reads with them. J went from reading 85 words Correct per minute to 94 in the first half of the year. S went from, 46 to 79 WCPM. B went from 23 to 47 WCPM (this student is actually on a 1st grade reading level....these scores indicate 4th grade readings!) A went from 93 to 154. They have all made amazing improvements. They should all be reading 123 WCPM by this time next year! Bill not only read with them, he asked questions, help them understand how to pay attention to what they are reading so they know the information. These last few weeks, Bill has worked with these students to improve their Times Table facts. He calls them out, does flash cards, has them take quizzes, and gives them pointers on how to be a better test taker. I really enjoyed having him as part of our class support. ~ Mrs. Warnick







### **PUBLIC CHARGE RULE**

In 2019, WIC was listed as exempt from the new Public Charge rule, meaning those who will be applying for a change of immigration status can use the WIC program without it affecting their immigration application.

Between April 2019-Dec 2019, the Provo WIC office sent 233 referrals to community resource providers in the South Franklin Partnership within the IRIS referral system.

### **CLIENT SATISFACTION**

Client Satisfaction Survey reported that 95.7% rated their experience at WIC as either good or excellent. 91% said they have made some behavioral changes since coming to WIC - the change with the largest percentage (69.6%) being eating more fruits and vegetables.

WIC has 12 Registered Dietitians, 3 Nutritionists, 1 IBCLC (International Board-Certified Lactation Consultant), and 24 Certified Lactation Educators on staff.



### THE CLEAN AIR TASK FORCE

The Clean Air Task Force was established to counteract Utah County's severe short-term air pollution in early 2014. The task force focuses on cleaner air for better quality of life. They seek solutions through coordination with local government agencies, elected officials, community leaders and businesses. Additionally, they strive to educate and motivate community members including students on measures they can take to reduce pollution to benefit not only family health, but also the economy in Utah Valley.

The task force seeks to educate and inform the public about clean air issues through community events, education through local schools and online resources, and alerting task force member to state legislation related to clean air.

Activities of the task force include acquiring and placing air-quality flag sets in many schools in Utah Valley and all Provo fire stations, posting air-quality information onto social media and local electronic billboards, educating the

public about new car smog ratings, supporting passage of a county limit on idling, encouraging state and local governments to support clean air measures, and sharing information with each other on how to improve air quality.

### UTAH VALLEY QUILT GUILD

The Utah Valley Quilt Guild was organized in January 1982 as a non-profit group to promote the art of quilting through educational and social means and now averages about 250 members.

A main purpose of the group is to give service and volunteer skills to the community. Each year the Guild donates fabrics and makes quilts to share with a variety of people in need. Some of the quilts have gone to homeless shelters, women's shelters, immigrants, police units, foster children, and a special love is the "Welcome Baby" program.

The quilts are either made by individual women in their homes, or the guild members come together to "mass" produce a large number of quilts in one day. In 2019 40 members, along with 13 sewing machines, lots of thread, and fabric, and pins, and needles came together at the County Administration Building in Provo and finished almost 70 quilts in one day! Those quilts were "walked" across the street to the Utah County Health Department Offices.

The Welcome Baby staff visits close to 2,000 high-risk families and high-risk infants a year. A Welcome Baby goal is to give each family a quilt and teach families about the importance of "Tummy Time" and literacy. The Utah Valley Quilt Guild over the last several years has provided close to 500 blankets for our Utah County families.
