



**ORDER TO TERMINATE THE
SEPTEMBER 22, 2020 UTAH COUNTY PUBLIC HEALTH ORDER**

Utah County, Utah

WHEREAS, pursuant to Utah Code § 26A-1-114 and Utah County Code 10-2-5, the Utah County Health Department (“Department”) Executive Director/Local Health Officer and pursuant to Utah Code § 53-2A-209, the Utah County Board of Commissioners did jointly issue the September 22, 2020 Utah County Public Health Order to ensure a coordinated implementation of practices which slow the transmission of COVID-19; and

WHEREAS, the Utah County Public Health Order was issued in response to the high level of positive COVID-19 cases in Utah County, and in an effort to cooperate with the Utah State Department of Health; and

WHEREAS, the State of Utah has recently transitioned from the phased guidelines to the COVID-19 Transmission Index and assigned Utah County to the high level of transmission; and

WHEREAS, the Department Executive Director/Local Health Officer and the Board of Commissioners recognize the need for Utah County and the public to continue to work cooperatively and proactively to slow the spread of COVID-19 also recognize there is no longer a need for a Utah County Public Health Order because the State of Utah has assigned Utah County to the high level of transmission and all individuals throughout Utah County are expected to adhere to the health guidance issued by the State of Utah.

NOW THEREFORE, pursuant to Utah Code § 26A-1-114 and Utah County Code 10-2-5, the Utah County Health Department Executive Director/Local Health Officer, Ralph Clegg, and pursuant to Utah Code § 53-2A-209, the Utah County Board of Commissioners, do jointly terminate the September 22, 2020 Public Health Order for Utah County.

As the State of Utah has transitioned to the COVID-19 Transmission Index and assigned Utah County to the high level of transmission, there is no longer a need to have in effect the Public Health Order for Utah County that was made effective September 22, 2020. All individuals throughout Utah County are expected to adhere to the health orders issued by the State of Utah.

This Order, terminating the September 22, 2020 Public Health Order for Utah County takes immediate effect. This Order shall be on file for public inspection with the Utah County Health Department.
