




# FRIENDS OF PUBLIC HEALTH



## UTAH COUNTY COMMISSION/KEY LEADERSHIP

Utah County Commission and leadership played an essential role in making policy decisions allowing the fast tracking of operational and logistics support needed for response. Key partners included Human Resources, Telecommunications, Public Works, IT, Purchasing, and the Auditor's office.

## UTAH COUNTY EMERGENCY MANAGEMENT

Utah County Emergency Manager, County Sherriff staff, along with UCHD Emergency Preparedness staff provided Personal Protective Equipment (PPE) distribution, identification of large scale clinic sites among other vital support functions.

## UTAH COUNTY IT DEPARTMENT

The IT department fast-tracked the ordering and installation of computers for contact tracing staff and later large site vaccination centers. They also helped develop the County's initial data dashboards and supporting later versions.

## UTAH COUNTY PUBLIC WORKS

The Public Works staff worked small miracles to turn THREE large empty spaces into safe and workable large scale vaccine distribution sites (Spanish Fork, Provo, and American Fork) with a very tight turn around time.

## BRIGHAM YOUNG UNIVERSITY

Brigham Young University (BYU) donated an ultra-cold freezer to the Health Department for the storage of Pfizer vaccine. BYU also made the former Provo High School available as a large school vaccination site. UCHD for eight months, the longest of all its large scale sites. BYU staff was exceptional through the entire process.

## ALPINE, NEBO & PROVO SCHOOL DISTRICT STAFF

Staff supported contacted tracing efforts and coordination with UCHD.

## UTAH NATIONAL GUARD

The Utah National Guard has been an active part of the the COVID-19 response in Utah County since early 2020. Guard members served over **10,000** hours in 2021. Effective COVID-19 response in Utah County could not have been done without the Utah National Guard.

## MEDICAL RESERVE CORPS

The COVID-19 response in Utah County would not have been possible without volunteers! **3,128** volunteers served over **19,000** hours in various roles from line monitors to registration to providing vaccinations. UCHD's MRC volunteers are truly AMAZING!

## UTAH COUNTY HEALTH DEPARTMENT STAFF

Most staff served in a COVID-19 response role. From contact tracing to the call center to assisting with immunization clinics, staff more than rose to the challenge of COVID-19 response.

# ADMINISTRATION



## NEW LEADERSHIP

The Board of Health appointed Eric Edwards as Department's new Director in early 2021. Tyler Plewe was appointed Deputy Director of the Department.

## COVID-19 RESPONSE

Directed new and existing department resources to the ongoing COVID-19 pandemic response, enabling staff to resume other key public health services such as environmental health, health promotion, and cancer screening.

## IMPLEMENTING ORGANIZATIONAL CHANGE

Implemented feedback from the 2021 employee engagement survey to seek future organizational changes that aim to: provide better support to staff, increase productivity, boost morale, retain employees, and offer enhanced professional development opportunities.

## IDENTIFY PRIORITY AREAS

Identified priority areas needing to be modernized through technology and other process changes. The Administrative team is supporting ongoing efforts within each Division to increase resources, realize efficiencies, and implement innovations to improve services offered to the public.













## LEADING CAUSES OF DEATH



## PANDEMIC RESPONSE









# SENIOR VOLUNTEERS

## FOSTER GRANDPARENTS

In 2021 **43** Foster Grandparent volunteers served **29,910** hours, tutoring and mentoring more than **896** students in Alpine, Nebo and Provo School Districts.

In 2021, Foster Grandparents started a Pen Pal program for those volunteers who could no longer serve in person. Four schools, three volunteers and 90 students are participating in the pilot program.

# WOMEN, INFANTS & CHILDREN



Average number of clients served per Month = **9,403**  
**112,846** clients provided healthy foods, nutrition education, and other health services.

## PUBLIC CHARGE RULE

In 2019, WIC was listed as exempt from the new Public Charge rule, meaning those who will be applying for a change of immigration status can use the WIC program without it affecting their immigration application.

## SOCIAL MEDIA

Increased presence on social media. Increased Facebook post frequency; including videos to promote Utah County WIC, including live videos, white board drawing video in English and Spanish, and promotion of the new WIC food package changes. Facebook followers have grown from 641 in 2020 to 1,100!

## BENEFITS INCREASED

Fruit and Vegetable benefits for WIC clients were increased in 2021. June-September = \$35.00 per month instead of \$9 for children and \$11 for women. An additional increase for October-September 2022 was approved = children \$9 increased to \$24 monthly, pregnant/ postpartum \$11 increased to \$43, breastfeeding women \$11 increased to \$47 per month.
